White Oak conserves and sustains some of the earth's rarest species through sustainable conservation breeding, education, and responsible land stewardship. Located along the St. Marys River in northeast Florida, 17,000 acres of mixed forest and wetlands make up the beautiful White Oak property. White Oak serves as a premier hub offering adults and students the opportunity to experience wildlife conservation first-hand through immersive conservation experiences and professional training programs. White Oak's education programs are based on a continuum model, offering early conservation exposure to younger students, then incrementally building conservation skills and leadership development through repeat exposure and specialized programing. White Oak is committed to providing equitable programing and inclusive environments for diverse student and professional audiences in all conservation education and professional training offerings.

Position Purpose:

The Program Associate works closely with the Conservation Program Manager and team members to plan, implement, and ensure the success and growth of the education programs at White Oak. The Program Associate is responsible for logistics and coordination of existing programs and actively contributes to the development and implementation of new programs, with particular focus on K-12 students. The Program Associate will predominantly oversee all elementary and middle school programs, with collaborative oversight of high school level programing. The Program Associate supports the conservation department through participation in all facets of the education programs including, but not limited to, developing and delivering education and training programs, developing and monitoring key performance and program metrics, communicating with internal departments and external partners, and marketing of programs.

Essential Responsibilities:

- Plan, implement, and manage White Oak K-12 programs, including curriculum development, facilitating and delivering interpretive programing, materials development, program evaluation, and coordination with partner organizations.
- Collaboratively plan, implement, and oversee Summer Camps including program content development and delivery, recruit and train seasonal staff, coordination with multiple departments, and ensure camper safety.
- Coordinate the logistics of Summer Camps and K-12 programs, including but not limited to planning, marketing, scheduling, registration, payment, client communications, and management of applications and medical records.
- Design and implement new conservation education programs for K-12 audiences, including the development and support of *in situ* conservation programs.
- Recruit education program participants.
- Develop and monitor key performance metrics and analytics to measure the success of education programs.
- Build White Oak's conservation network through developing and maintaining key strategic partnerships with diverse external stakeholders to maintain and grow meaningful and impactful programs.
- Leverage White Oak's unique campuses, wildlife, staff expertise, and broad network of partners to best impact conservation through education programs.
- Coordinate and communicate with internal departments to facilitate specialty experiences, guest transportation and meals, housing accommodations, and all other education programing needs.
- Deliver education programming for all White Oak audiences (K-12, college, and adult) including delivering tours and supporting events.
- Prepare written reports, work plans, grants, budgets, brochures, articles and other publications.
- Maintain updated education records, provide details required to manage budgets, compile program summaries and reporting.
- Work closely with White Oak leadership and the Conservation Program Manager to coordinate strategies for education programs.
- Design and prepare educational aids, binders, and necessary materials for education programs.
- Ensure the safety and well-being of guests, staff, and wildlife.
- Transport guests within and outside of White Oak.

• Perform all other related duties as assigned.

Key Qualifications:

- 3+ years of experience in environmental education and/or wildlife conservation program work.
- Experience working with children, with preference given to experience in informal learning environments.
- Willing to be trained in CPR, First Aid, and AED adult and pediatric certification
- Must hold a valid driver's license
- Candidates must submit and pass a Level II background check and submit an affidavit of good moral character (Florida Department of Children and Families)
